I also agree to take any and all responsibility for all damages whatsoever caused to third persons or their belongings, to myself or to my belongings, ashore and at sea as a consequence of my participation in the regatta, and hereby relieve from any responsibility, and agree to indemnify on a full indemnity basis and hold harmless, the Norddeutscher Regatta Verein, NRV Marketing GmbH, MAL Events and their servants, agents and sponsors, the Class Associations and their representatives in respect of any claim arising there from.

I am acquainted with ISAF Part 1 Fundamental Rule 4: "A boat is solely responsible for deciding whether or not to start or to continue racing". In any case, I agree that the Norddeutscher Regatta Verein, the NRV Marketing GmbH and MAL Events, their employees, volunteers, servants, agents and sponsors, the Class Association and their representatives have no responsibility for loss of life or injury to members or others, or for the loss of, or damage to any vessel or property.
